Minutes:

President Schwarm presented the minutes of the February 3, 2023, meeting. Motion by Director Judy seconded by Chairman Lannon, to approve the minutes.

The motion was approved.

Motion by Chairman Forsyth, second by Director Huff to approve the Treasurer's report as presented. The motion was approved.

Committee Reports

Arrangements:

Chairman Lannon advised that Pilgrim Pines had some winter issues, mostly leaking roofs. No additional tree damages. The camp has a new chef and there will be different menus. Meal quality will be better.

CAL FIRE Yucaipa BC contacted for medical coverage during the conference. A new condition of the ABC permit is to have a certified Server on site. Lannon advised he took the course and test himself and got the certification needed so we are covered. The fees were \$83.50 for the course. A motion was made by Chairman Forsyth and seconded by Chairman Snow to reimburse Lannon for the costs. Motion passed.

A reminder to all that all cans and bottles must be removed from the conference site by Friday morning. The Sheriff's Captain was contacted to sign the permit and will provide the safety message. Luther Glen rooms not available this year, but parking is available. Parking tender contacted. The upper parking lot will be restricted to displays only. Crew will be from LA County Fire. Ventura County Fire will provide two crew buggies for shuttle. Apartments below Kitchen available to store raffle. Health Center has been upgraded. Sam Conn from LLAC will help with IT/AV. Microphones will need to be rented. VP Trevor Johnson made a motion to expend up to \$500 for remote mic rentals. Seconded by Forsyth. Motion passed.

The Oak Glen Steakhouse has re-opened after the mud and debris damage. They will be the site of the Directors Dinner Wednesday night. Food will be ordered off the menu. The signs are ready to go at Oak Glen Camp. RRU Director McDermott will get the radio cache again. Director Black will be arranging the 20x40 tent.

VP Johnson advised if anyone has new vehicles to display let Trevor know. There will be multiple vendors displaying.

Registration and Membership:

VP Fowler reported 27 registrations so far. Square is working well for this. Purchased two point of sale plugs. Larry will be coming to help again. Abby Forest also said she would assist with registration.

Entertainment and Raffle:

Director Spelman has the raffle and entertainment in progress. The tickets will be single number sheets. Working on some donations.

Publicity:

Director Judy is working with Megan Currier on the social media ads. Google drive with photos needed.

Historian:

Director Whitman was absent so no report.

Safety:

Safety Chairman Forsyth advised everything is ready. Suggestion to have some hand sanitizer stations around the camp especially near the kitchen. Also suggested that we provide water during the day so attendees can stay hydrated. Some signage is needed for the bathrooms, etc.

Golf:

Director Spelman had no report. No golf this year.

The new newsletter format seems to be accepted. Need content as usual.
