President Fry advised that he wanted to have a call to discuss a field trip that some directors made to King Gillete Ranch in the Santa Monica Mountains as a potential conference location and board meeting location.

Report from Lannon on Oak Glen and Pilgrim Pines, which survived recent debris flows in the area. Oak Glen Road is good, and the Steakhouse is also open for business. Chris the director of the camp received \$5 million for improvements to the camp, including roofs, asphalt, and moving the pool.

King Gillette Ranch

Field trip attendees (Smith, Fry, Lannon, Forsyth, Snow) reported the layout of the camp is more spread out than Pilgrim Pines. Lots more walking between venue and mess hall etc. Camp will sleep 180 persons. Accommodations are less rustic but smaller. Common bathroom on each floor. Stairs are marble and look slippery. Leadership quarters are separate. Large presentation/theatre area, including padded Theatre seats. Projector and PA are all built in. Power is available outside for vendors.

Some drawbacks are the stairwell (no elevator), the long walks, potentially higher cost, kitchen requires the hiring of a vendor/caterer, trash removal is the responsibility of the user. Director Smith advised the County could assist with most of the logistical issues. The venue will probably work with the association as far as cost.

Questions will have to be solved before further discussion about using it for a conference venue. A discussion was had about having the December Board of Directors meeting there, but it was determined that the December meeting is too important to have a tour of the facility as a distraction. More discussion at the December Board meeting. Director Kennison will send out details later for Bakersfield.
